

### WEBSITE TERMS AND CONDITIONS OF USE

### 1. About the Website

- (a) Welcome to Infinite Skills Hub (**Website**). The Website is Industry Learning Courses (**Services**).
- (b) The Website is operated by Infinite skills hub proprietary Itd. (ACN 68673864278). Access to and use of the Website, or any of its associated Products or Services, is provided by Infinite skills hub proprietary Itd.. Please read these terms and conditions (**Terms**) carefully. By using, browsing and/or reading the Website, this signifies that you have read, understood and agree to be bound by the Terms. If you do not agree with the Terms, you must cease usage of the Website, or any of Services, immediately.
- (c) Infinite skills hub proprietary ltd. reserves the right to review and change any of the Terms by updating this page at its sole discretion. When Infinite skills hub proprietary ltd. updates the Terms, it will use reasonable endeavours to provide you with notice of updates to the Terms. Any changes to the Terms take immediate effect from the date of their publication. Before you continue, we recommend you keep a copy of the Terms for your records.

## 2. Acceptance of the Terms

You accept the Terms by remaining on the Website. You may also accept the Terms by clicking to accept or agree to the Terms where this option is made available to you by Infinite skills hub proprietary ltd. in the user interface.

## 3. Registration to use the Services

- (a) In order to access the Services, you must first register for an account through the Website (Account).
- (b) As part of the registration process, or as part of your continued use of the Services, you may be required to provide personal information about yourself (such as identification or contact details), including:
  - (i) Email address
  - (ii) Preferred username
  - (iii) Telephone number
  - (iv) Password

- (c) You warrant that any information you give to Infinite skills hub proprietary ltd. in the course of completing the registration process will always be accurate, correct and up to date.
- (d) Once you have completed the registration process, you will be a registered member of the Website (**Member**) and agree to be bound by the Terms.
- (e) You may not use the Services and may not accept the Terms if:

# 4. Your obligations as a Member

  - (i) you have breached any provision of the Terms or intend to breach any provision;
  - (ii) Infinite skills hub proprietary ltd. is required to do so by law;
  - (iii) the provision of the Services to you by Infinite skills hub proprietary ltd. is, in the opinion of Infinite skills hub proprietary ltd., no longer commercially viable.

### 14.1. Compulsory:

### 14.2. Notice:

A party to the Terms claiming a dispute (**Dispute**) has arisen under the Terms, must give written notice to the other party detailing the nature of the dispute, the desired outcome and the action required to settle the Dispute.



#### 14.3. Resolution:

On receipt of that notice (**Notice**) by that other party, the parties to the Terms (**Parties**) must:

- (a) Within 28 days of the Notice endeavour in good faith to resolve the Dispute expeditiously by negotiation or such other means upon which they may mutually agree;
- (b) If for any reason whatsoever, 28 days after the date of the Notice, the Dispute has not been resolved, the Parties must either agree upon selection of a mediator or request that an appropriate mediator be appointed by the \_\_\_\_\_
- (c) The Parties are equally liable for the fees and reasonable expenses of a mediator and the cost of the venue of the mediation and without limiting the foregoing undertake to pay any amounts requested by the mediator as a precondition to the mediation commencing. The Parties must each pay their own costs associated with the mediation;
- (d) The mediation will be held in , Australia.

### 14.4. Confidential

All communications concerning negotiations made by the Parties arising out of and in connection with this dispute resolution clause are confidential and to the extent possible, must be treated as "without prejudice" negotiations for the purpose of applicable laws of evidence.

### 14.5. Termination of Mediation:

If 2 months have elapsed after the start of a mediation of the Dispute and the Dispute has not been resolved, either Party may ask the mediator to terminate the mediation and the mediator must do so.

# 15. Venue and Jurisdiction

The Services offered by Infinite skills hub proprietary ltd. is intended to be viewed by residents of Australia. In the event of any dispute arising out of or in relation to the Website, you agree that the exclusive venue for resolving any dispute shall be in the courts of Victoria, Australia.

### 16. Governing Law

The Terms are governed by the laws of Victoria, Australia. Any dispute, controversy, proceeding or claim of whatever nature arising out of or in any way relating to the Terms and the rights created hereby shall be governed, interpreted and construed by, under and pursuant to the laws of Victoria, Australia, without reference to conflict of law principles, notwithstanding mandatory rules.
